Objectives and investment policy

The Fund aims to provide long-term total returns (the combination of income and capital growth).

The Fund invests around the world in a broad range of assets including: equities (e.g. the shares of companies); bonds (contracts to repay borrowed money which typically pay interest at fixed times); commodities, property and other alternative assets (such as infrastructure funds and private equity funds), derivatives, transferable securities and in other funds. The Fund may hold cash.

Investments may be directly (e.g. using derivatives) in the assets themselves (excluding property and commodities) or indirectly.

Bonds may be issued by any issuer (e.g. governments or companies), including emerging and frontier type markets.

The Fund may invest in mainland China without limitation, including bonds traded on the China Interbank Bond Market and companies traded on Stock Connect (a share trading link between the Hong Kong Stock Exchange and China's mainland markets).

The Investment Manager may at times utilise global equities (proxied by the MSCI All Country World Total Return Net Index), global government bonds (proxied by the FTSE World Government Bond Index), or a combination of both, as a comparator to measure the risk, return or yield characteristics of the Fund.

The Fund promotes environmental and social characteristics in line with Article 8 of the EU Sustainable Finance Disclosure Regulation (SFDR).

The Fund will not invest in certain sectors or investments. Over time, the Investment Manager may, in accordance with the Fund's investment objective and policy, apply additional exclusions to be disclosed on the website, as they are implemented.

Derivatives (financial contracts whose value is linked to the price of an underlying asset) may be used in order to achieve the Fund's investment objectives or with the aim of either managing the Fund risks or reducing the costs of managing the Fund.

The Fund is actively managed. This means the Investment Manager is free to select investments with the aim of achieving the Fund's objectives.

Any income due from your investment is reflected in the value of your shares. You can typically buy or sell shares in the Fund on any business day.

Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

The Fund appears towards the middle of the Risk and Reward Indicator scale. This is because the mix of assets the Fund invests in, tends to produce returns which fluctuate more than those of cash funds but less than those of funds which solely invest in the shares of companies.

Risks that may not be fully captured by the Risk and Reward Indicator:

- Currency exchange:** Changes in the relative values of different currencies may adversely affect the value of investments and any related income.
- Default:** There is a risk that the issuers of fixed income investments (e.g. bonds) may not be able to meet interest payments nor repay the money they have borrowed. The worse the credit quality of the issuer, the greater the risk of default and therefore investment loss.
- Derivatives:** The use of derivatives may increase overall risk by magnifying the effect of both gains and losses leading to large changes in value and potentially large financial loss. A counterparty to a derivative transaction may fail to meet its obligations which may also lead to a financial loss.
- Emerging and Frontier market (inc. China):** These markets carry a higher risk of financial loss than more developed markets as they may have less developed legal, political, economic or other systems.
- Equity investment:** The value of equities (e.g. shares) and equity-related investments may vary according to company profits and future prospects as well as more general market factors. In the event of a company default (e.g. insolvency), the owners of their equity rank last in terms of any financial payment from that company.
- Government securities exposure:** The Fund may invest more than 35% of its assets in securities issued or guaranteed by a permitted sovereign entity, as defined in the definitions section of the Fund's prospectus.
- Interest rate:** The value of fixed income investments (e.g. bonds) tends to decrease when interest rates rise.

Charges

The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

The entry charge shown is the most you might pay, in some cases you might pay less.

You can find out actual entry charges from your financial adviser.

The ongoing charges figure is based on last year's expenses for the year ending 31 December 2024. The figure excludes any performance fee and portfolio transaction costs, except in the case of an entry or exit charge paid by the Fund when buying or selling units in another fund. Ongoing charges may vary from year to year.

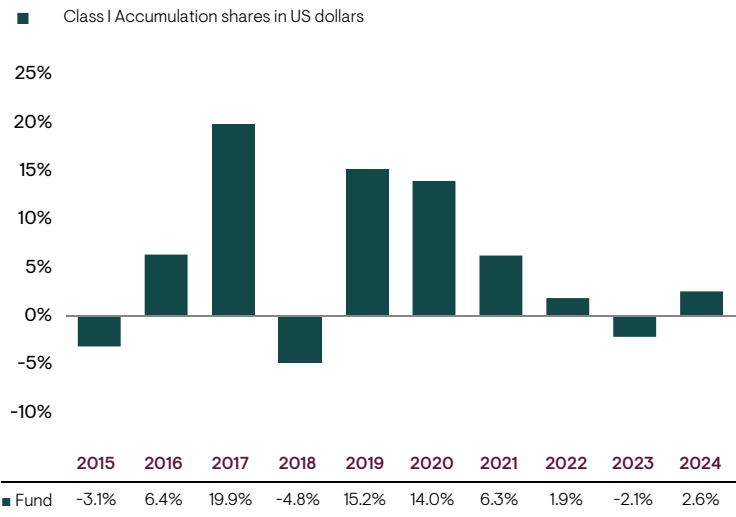
Past Performance

As the Fund's investment objective and policy changed as part of the merger, performance prior to this date was achieved under different circumstances. On 02 June 2020 the Fund changed its name from Global Multi-Asset Total Return to Global Macro Allocation.
