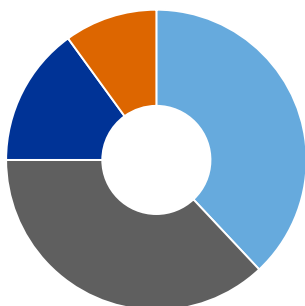

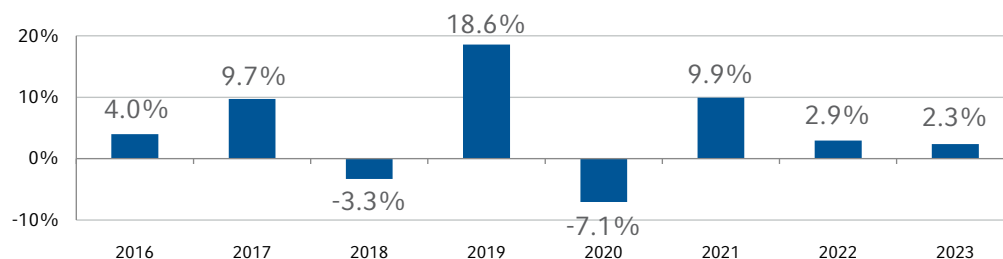
Investment strategy
