THE PORTFOLIO

The portfolio aims to generate capital growth greater than the rate of inflation (CPI) over the long term (more than five years) with a low to medium level of volatility. Around half of the portfolio invests in equities and a third in fixed income, with the remainder in alternatives and cash/money market funds. Most of the equities invest in developed markets and there is exposure to Asia and emerging markets.

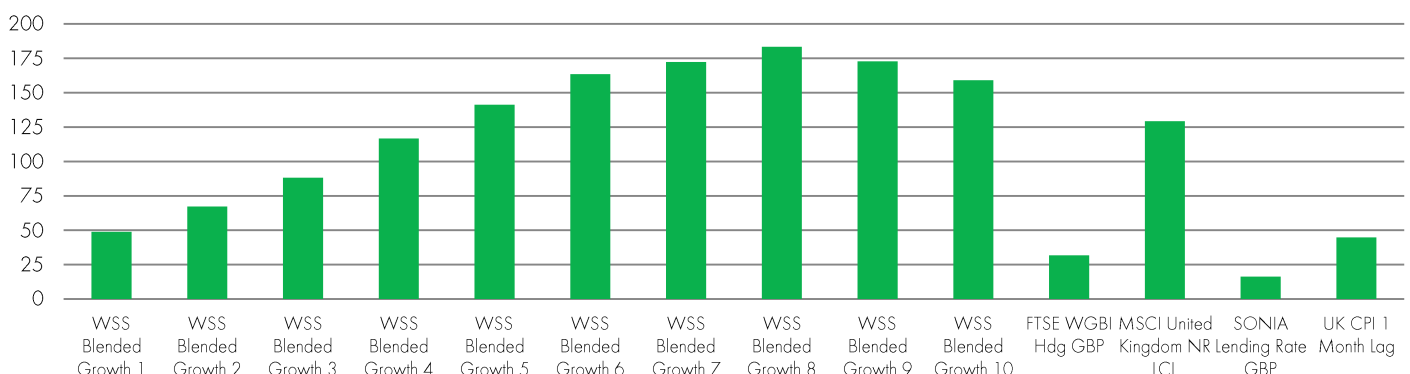

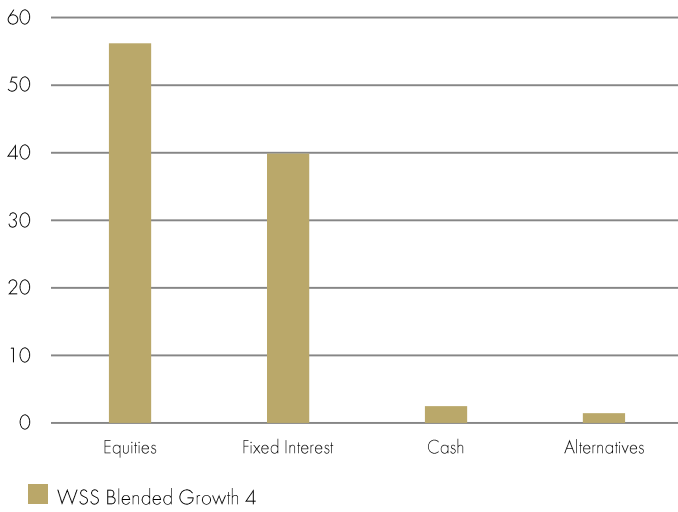
