THE PORTFOLIO

The portfolio aims to grow capital at least in line with the rate of inflation (CPI) over the long term (more than five years) with a low level of volatility. Around a quarter of the portfolio invests in cash and money market funds, a third in bonds and the remainder largely in equities, with the potential for a small allocation to alternatives. The majority of the equity allocation invests in developed markets.




PERFORMANCE SINCE LAUNCH (%)


ASSET ALLOCATION WEIGHTINGS (%)
