What is this product?

Type:

This product is a UCITS Fund.

Term:

The Fund, unless dissolved pursuant to any specific cause set forth in a mandatory law or in accordance with the prospectus of the Fund, is established for an unlimited duration.

Objectives:

The objective of the Fund is to provide long-term capital appreciation while giving investors exposure to clean infrastructure companies that are solving environmental challenges and improving operational characteristics such that positive, direct, and measurable environmental outcomes are achieved.

Investments in equity securities are limited to shares of Clean Infrastructure companies. The Sub Investment Manager defines Clean Infrastructure companies as infrastructure companies that derive most of their revenues or invest most of their assets in projects supporting the energy transition (for example, renewable energy and railroads), the provision and/or recycling of water, or the management of waste and/or environmental remediation. The Fund considers these companies to be solution providers to overarching global objectives: climate change mitigation, the development of a circular economy, and water security and availability. All investments are additionally subject to minimum ESG performance rating, ESG exclusions and are subject to the Sub Investment Manager's proprietary Impact Framework.

The Fund invests at least 80% of its assets in equity securities of global infrastructure companies and companies with associated businesses. The Fund expects to invest at least 25% of its assets in non U.S. infrastructure companies, and may invest up to 25% of its assets in issuers from emerging markets.

Investments in fixed income securities are limited to securities issued by clean infrastructure companies meeting the minimum ESG performance rating and/or which directly finance projects aligned with the above objectives.

The Fund generally invests in companies that, - in addition to meeting the minimum ESG performance rating and Impact Framework eligibility - also meet one or more criteria, based on the Sub Investment Manager's own determination, including but not limited to consistent growth, and attractive valuations (companies that may be undervalued by the market, relative to their assets and earnings).

The Fund has a sustainable investment objective and operates in accordance with Article

9 of SFDR.

The Fund is actively managed and uses a blended benchmark index comprising the S&P Global Infrastructure Index and S&P Global 1200 Utilities (Sector) Capped Index (the "Benchmark") for performance comparison purposes. While a proportion of the Fund's assets may from time to time be components of and have similar weightings to the Benchmark, the Sub Investment Manager has discretion in the selection of investments for the Fund and may invest in securities that are not included in the Benchmark. In addition, the Benchmark employs different investment guidelines and criteria than the Fund. As a result, the holdings in the Fund may differ significantly from the assets that comprise the Benchmark and the volatility of the Benchmark presented may be materially different from that of the performance of the Fund.

The Fund may invest in financial derivative instruments ("FDI"), which are financial instruments linked to the value of underlying assets. FDI may be used for, e.g., managing the Fund's exposure to foreign currencies, reducing risk, managing the Fund more efficiently and to achieve profit. At times, the Fund may invest in cash and instruments that can be readily converted into cash.

Any income the Fund generates will be reinvested to grow the value of your investment.

You may purchase or sell shares of the Fund on days on which both the New York Stock Exchange and retail banks in Ireland are open for business, subject to certain cut-off times.

This document describes a sub-fund of the Company. The prospectus and periodic reports are prepared in respect of the entire umbrella Company. The assets and liabilities of each sub-fund of the Company are segregated by law, and so the assets and liabilities of one sub-fund cannot be used to discharge the liabilities of another sub-fund. Each investor of the Fund may apply to exchange shares in the Fund for shares in another sub-fund of the Company as set out in the Prospectus.

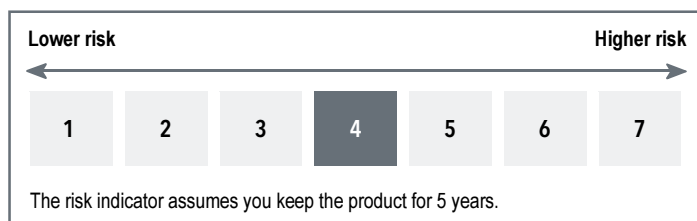
The assets of the Fund are held in safekeeping by its depository, Brown Brothers Harriman Trustee Services (Ireland) Limited (the "Depository").

Intended retail investor:

The Fund may be appropriate for investors who have a long-term investment horizon. What are the risks and what could I get in return?

Risk Indicator



The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level and poor market conditions could impact the Fund's capacity to pay you.

Performance scenarios
