### THE PORTFOLIO

The portfolio aims to generate capital growth greater than the rate of inflation (CPI) over the long term (more than five years), with a low level of volatility. Around half or more of the portfolio invests in fixed income. There may also be small allocations to cash/money market funds and alternatives. The portfolio predominantly, although not exclusively, uses passive strategies.




