The portfolio predominantly, although not exclusively, uses passive strategies.

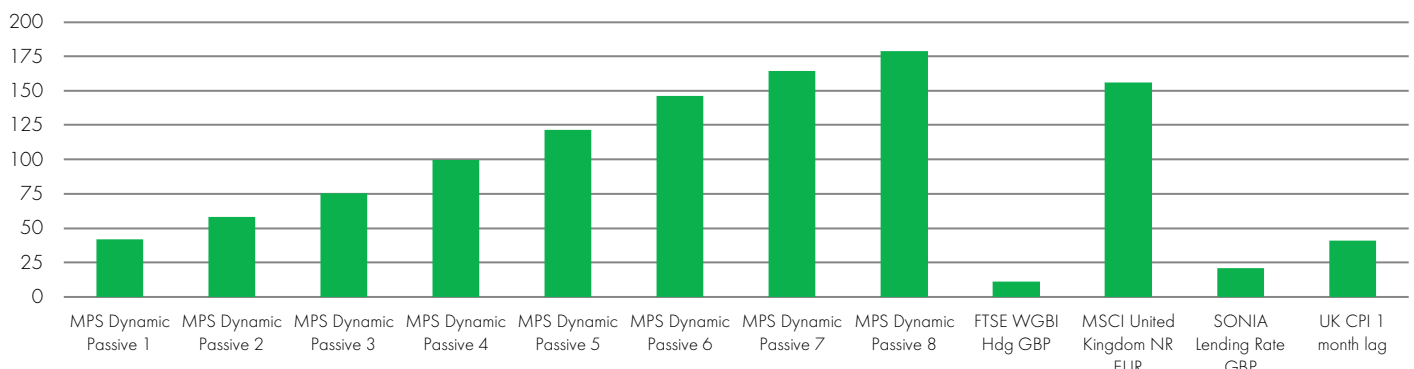

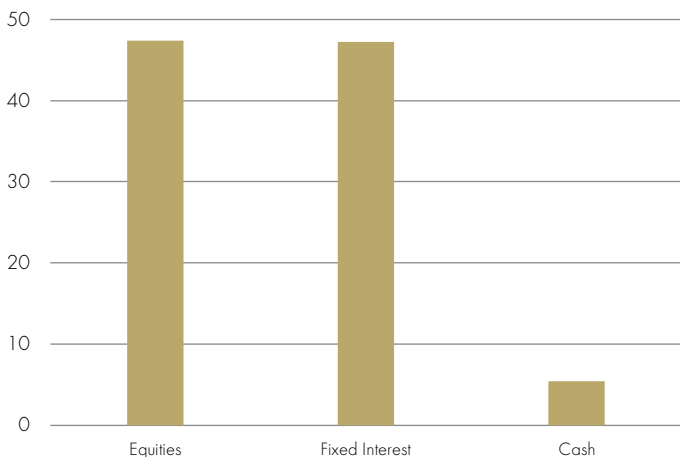
