THE PORTFOLIO

The portfolio aims to generate capital growth greater than the rate of inflation (CPI) over the long term (more than five years), with a low level of volatility. The portfolio predominantly, although not exclusively, uses passive strategies.

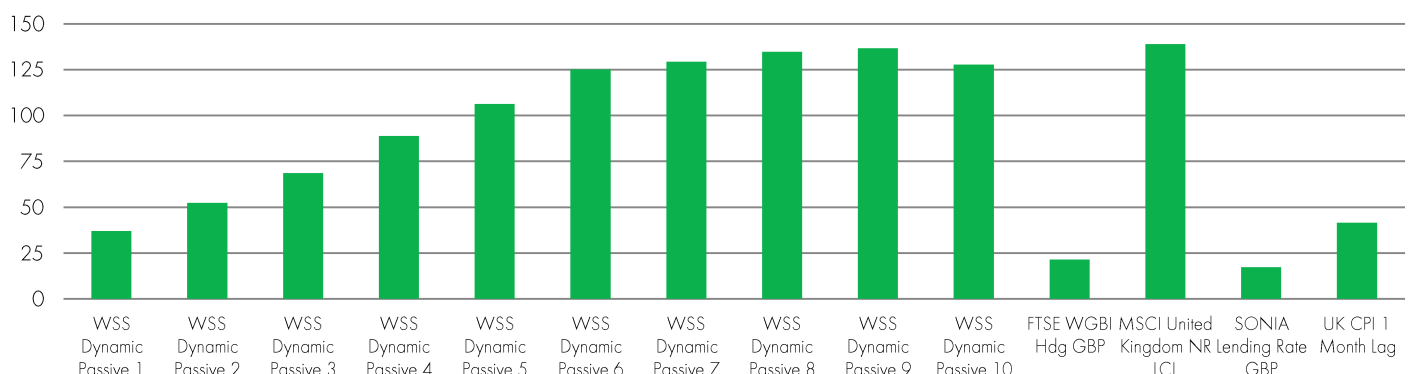

PERFORMANCE SINCE LAUNCH (%)

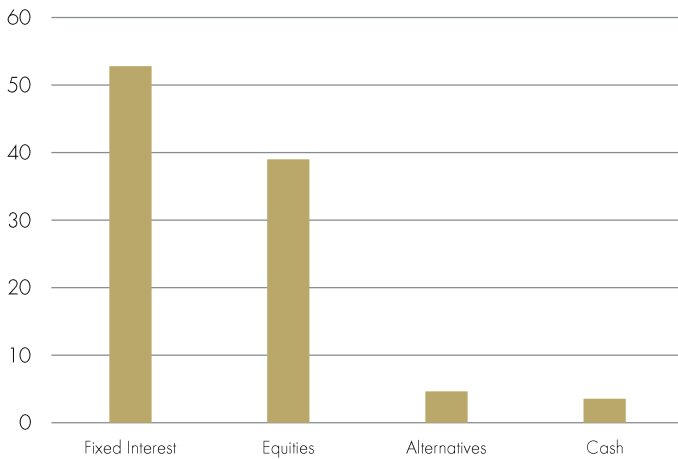
