## THE PORTFOLIO

The portfolio aims to grow capital in line with the rate of inflation (CPI) over the long term (more than five years), with a low level of volatility. Around half the portfolio is invested in cash and money market funds, with the rest in fixed income, equities and a potentially small exposure to alternatives. The majority of the equity allocation is in developed markets. The portfolio predominantly, although not exclusively, invests in passive strategies.

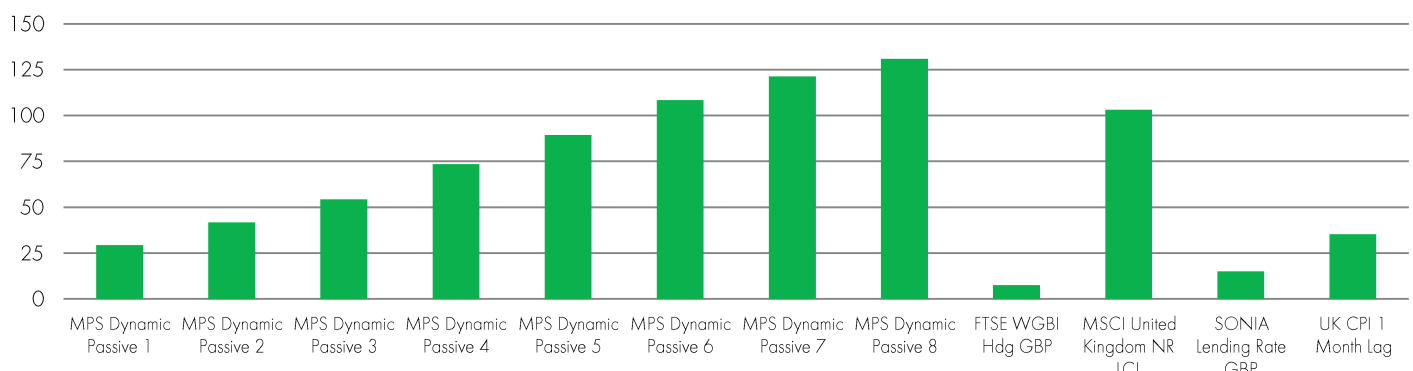

## PERFORMANCE SINCE LAUNCH (%)

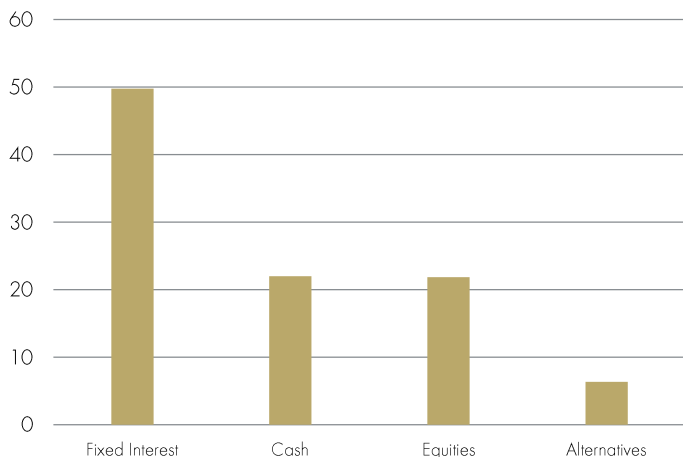
