### High Growth Potential

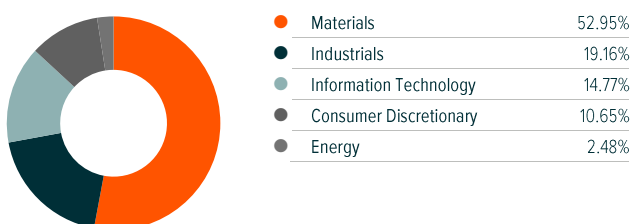

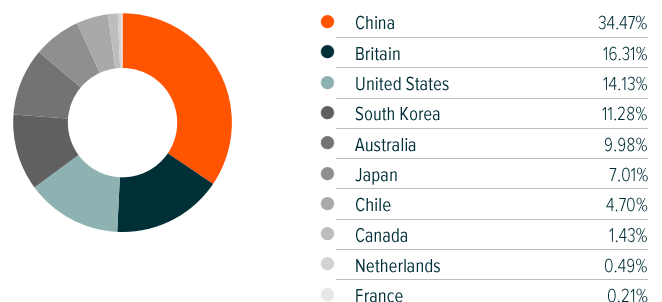
