## What is this product?

Type A class of shares of a sub-fund of GSF which is a Société d'Investissement à Capital Variable (SICAV) under the laws of Luxembourg.

**Term** Open-ended. Ninety One Luxembourg S.A. cannot terminate the share class, sub-fund or GSF unilaterally but the GSF directors may subject to closure processes set out in the prospectus.

**Objectives** To provide a high level of income with the opportunity to grow the value of your investment over the long term.

Investment policy Invests primarily in a range of bonds issued by Latin American governments, institutions or companies, in or with material links to the Latin American region. The Fund's investments may be issued in Latin American local currencies as well as globally traded major currencies. The Fund may invest in other assets and may hold cash.

Sustainability approach – Article 8 SFDR The Fund promotes environmental and social characteristics in line with Article 8 of the EU Sustainable Finance Disclosure Regulation (SFDR) by making investments in borrowers that meet the standards of the Investment Manager's proprietary sustainability framework and by excluding investments in certain borrowers.

Benchmark(s) The Fund is actively managed. The Investment Manager is free to select investments with the aim of achieving the Fund's objectives. The JPMorgan CEMBI Broad Diversified Latin America Index is used for performance comparison. The Fund does not seek to replicate the index. It will generally hold assets that are components of the index, but not in the same proportions, and it is allowed to hold assets which are not components of the index. The assets of the Fund therefore may be very different from the index.

Practical details The Fund's returns depend on the performance of its underlying investments and it does not provide protection against investment losses caused by financial market fluctuations. Any income due from your investment is paid out to you. GSF's Depositary is State Street Bank International GmbH, Luxembourg Branch. #### Glossary of terms

**Bonds** Tradable contracts issued by governments or companies to repay borrowed money and typically pay interest at fixed periods.

The Fund has been designed to form part of a broader portfolio of investments and can be purchased with advice or on an execution only basis by a basic investor. This share class of the Fund is only available to an investor that qualifies as an 'institutional investor' under Luxembourg administrative practice and can be purchased with advice, on an execution only basis or when providing portfolio management services. Investors must be able to bear loss of capital in order to seek to generate higher potential returns and should be prepared to remain invested for at least 5 years.
