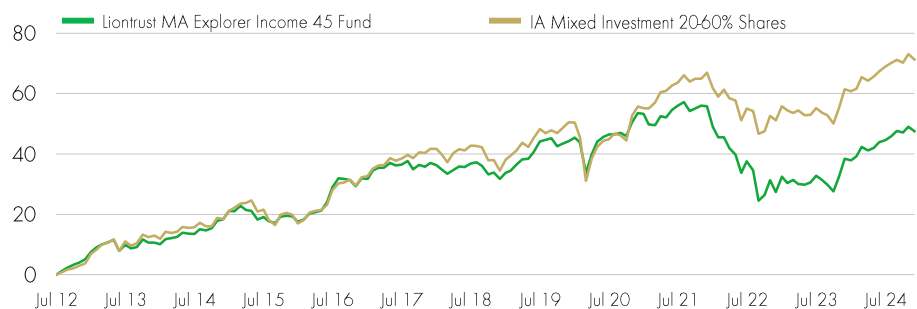

## PERFORMANCE SINCE CLASS LAUNCH DATE (%)



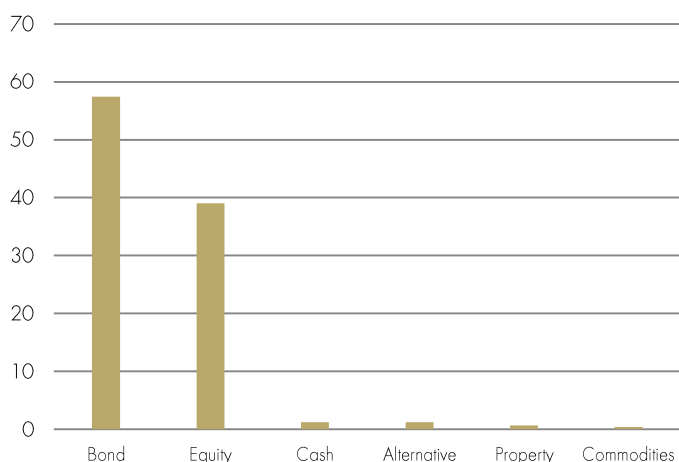
