Objective

To grow capital over a five year period.

Investment policy

What the fund invests in

- 80% to 100% in shares of smaller companies.
- Up to 20% in bonds, cash and near cash, other transferable securities, other funds (up to 10%) managed by Artemis and third party funds, money market instruments, and derivatives.

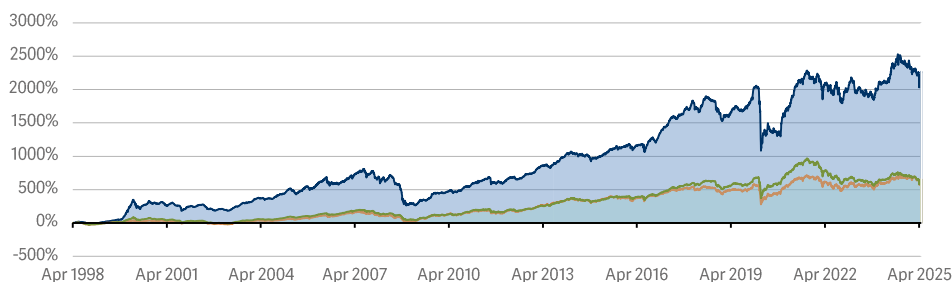

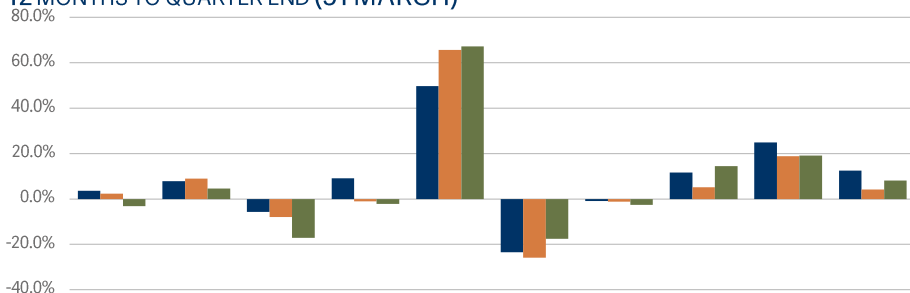

PERCENTAGE GROWTH



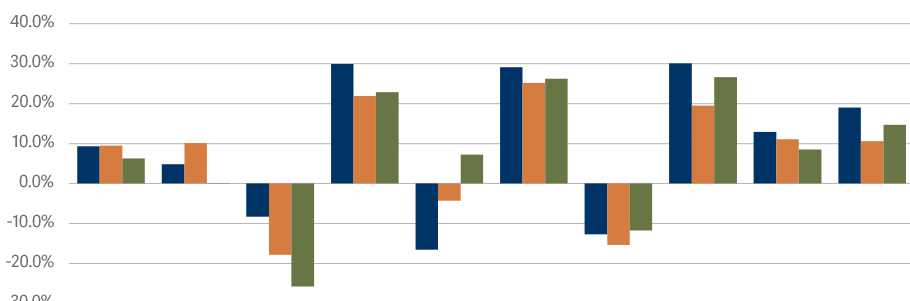

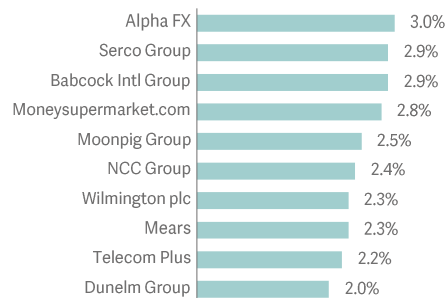

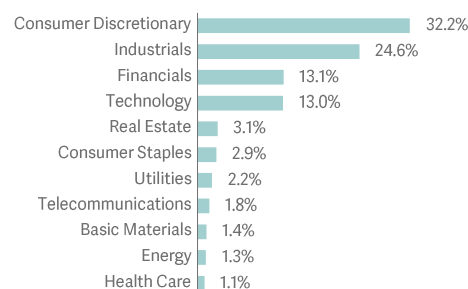

TOP 10 HOLDINGS



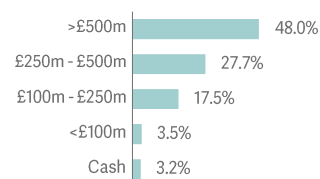
