The Trust, which was established in 1889, aims to invest primarily in UK securities with the long-term objectives of achieving an increase of the Net Asset Value per share in excess of the growth in the FTSE All-Share Index and growth in dividends per share in excess of the rate of UK inflation. The Liontrust Portfolio Managers construct a high-conviction portfolio of 40 to 50 holdings based on fundamental company research. The team's flexible investment process delivers a differentiated, diversified portfolio of listed equities.

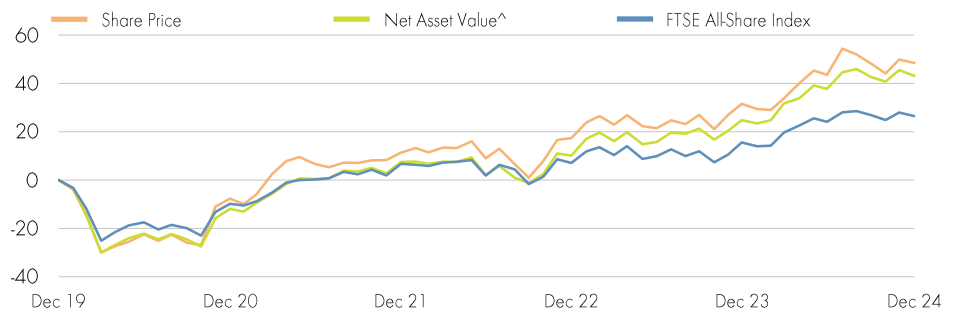

GLOSSARY

Gross Gearing: This reflects the amount of gross borrowings in use by a company and takes no account of any cash balances. It is based on gross borrowings as a percentage of net assets. Borrowings are at fair value.

Historic dividend per share: Dividends that have gone ex-dividend over the last 12 months (exclusive of special dividends).

Historic share price yield: Historic dividend per share divided by the share price (exclusive of special dividends).

Net Gearing: Net gearing reflects the amount of net borrowings
