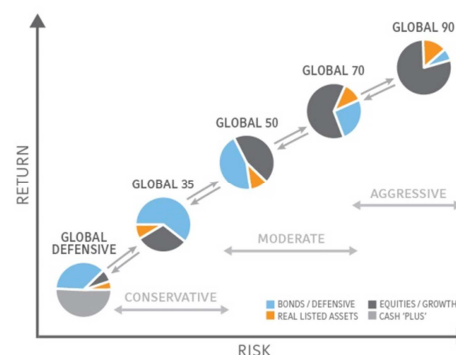

The fund invests 90% of total value in growth assets (Equities and Real Assets) and the remaining in fixed income and cash based strategies

Individual managers are also monitored and adjusted to ensure we have our pick of the best managers, styles and strategies.
